Keith Tribe is a private scholar and translator, and also a rowing coach at The King's School, Worcester. He was born in London in 1949, and is a graduate of the Universities of Essex and Cambridge. During the early 1980s he was a Visiting Fellow of the Max Planck Institut für Geschichte in Göttingen, subsequently teaching economics at the University of Keele, retiring as Reader in Economics in 2002. His most recent publications are an essay on the cameralistic sciences in the *Cambridge History of Eighteenth-Century Political Thought* (Cambridge: Cambridge University Press, 2006), and a new paperback version of *Strategies of Economics Order: German Economic Discourse 1750–1950* (Cambridge: Cambridge University Press, 2006); he is currently preparing an essay on 'British Economics in the Twentieth Century' for the revised edition of the *New Palgrave Dictionary of Economics* (Palgrave Macmillan, 2007).

Hinnerk Bruhns is CNRS director of research in Paris and deputy director of the Fondation Maison des Sciences de l'Homme. He was born in Bielefeld in 1943, and completed his doctorate at the University of Cologne. During the 1970s he taught ancient history at the Universities of Cologne and Bochum, and since the late 1980s he has taught German historiography and history of the social sciences of the 19th and 20th centuries at the École des Hautes Études in Paris. Among his most recent publications are two volumes edited by him: *Histoire et économie politique en Allemagne de Gustav Schmoller à Max Weber. Nouvelles perspectives sur l'école historique de l'économie* (Éditions de la Maison des sciences de l'homme, Paris 2004), and (edited in collaboration with Jean Andreau): *Sociologie économique et économie de l'Antiquité : à propos de Max Weber*.
